Day 1: You will stop at the world's largest Christmas store, **Bronner's** and spend the night near **Frankenmuth, Michigan** today. This evening, enjoy the **Bavarian Inn's** famous chicken dinner. (D)

Day 2: Travel to **Mackinaw City** to board a ferry which will cross Lake Michigan to **Mackinac Island**. Your home for the next two nights will be at a **Victorian hotel on the main street**. (CB,L,D)

Day 3: Your stay on the Island will include an **elegant island tour by horse-drawn carriage**, driving by such sights as **Skull Cave, Arch Rock and the Beaumont Memorial**. The highlight of the day will be the seemingly endless buffet luncheon at the **Grand Hotel**. Don't forget to sample some of the famous Mackinac fudge. Free time this afternoon and evening. (B,L,D)
