Day 1: Travel to **Charlotte, NC** for an overnight.

Day 2: Depart for **Charleston, SC**, a city rich in history, tradition and Southern charm. Enjoy a tour of the **Yorktown Aircraft Carrier at Patriots Point Naval and Maritime Museum**. Then take a **guided tour of Mt. Pleasant, Sullivan's Island and the Isle of Palms**. Your home for the next three nights will be in **Mt. Pleasant, SC**. (CB,BL)

Day 3: Today, you will be treated to a **guided city tour** and a **horse-drawn carriage tour in the historic district**. Then enjoy free time in **The Market** and a cruise to **Ft. Sumter**. (CB,D)

Day 4: Visit **Magnolia Plantation with a tram tour of the Audubon Swamp** and a **tour of the mansion**. Also, visit the **Charleston Tea Plantation** this afternoon. (CB,D)
