At **Catalba Grove Market** you will find more goodies, a mixture of apples and other seasonal fruits, as well as good old fashion baked goods. Receive a sweet bakery treat.

Lunch at the historic **Spread Eagle Tavern**. Take a self-guided tour of this restored federal-style three story building built in 1837. Each room is decorated in period furnishings. Self-guided tour is subject to current COVID-19 regulations.

Welcome to one of the largest farm markets in the state of Ohio - the **White House Fruit Farm**. The first thing you will notice is the smell of cookies, pies and their wonderful blueberry doughnuts. You will receive a doughnut, drink and a small bag of apples.

Visit the **Maize Valley Winery** for a wine tasting. Shop the market for sauces, salsas, jams, jellies, and more. Receive whiskey sticks. (L)
