Day 2: Start your day with a visit to the Gettysburg National Military Park Visitor's Center (admission includes the museum, *New Birth of Freedom*, and Cyclorama program). Later this morning, a licensed stepon guide with take you on a battlefield tour. Dinner tonight is at the historic Dobbin House Tavern followed by the Ghosts of Gettysburg walking tour. (CB,D)

Day 3: Visit the **Shriver House Museum**, a 19th-century home of a Civil War soldier's family where you will explore the civilian experience. Before departing for home, stop at the newest museum in Gettysburg, **Beyond the Battle Museum**. See, hear, and feel what it was like for the civilians of Gettysburg inside *Caught in the Crossfire*, a 360 -degree immersive Battle of Gettysburg experience. (CB)
