Day 1: Travel to the wonderful **Outer Banks** where you will stay for **four nights in Corolla, NC.** (D)

Day 2: Enjoy a **Wild Horse Adventure Tour**, searching for the last remaining herd of wild banker ponies via "oversize hummers!" Visit nearby **Currituck Beach Lighthouse** (climbing is optional for an additional fee). Afternoon is yours to enjoy the beach and hotel pool. (CB,D)

Day 3: Today, visit the **Wright Brothers National Park & Monument.** Lunch and free time in the quaint waterfront village of **Manteo.** Enjoy **Roanoke Island Festival Park** and all it has to offer: sailing ship **Elizabeth II**, the **Settlement Site**, **American Indian Town**, and **Adventure Museum**, plus learn more about the Lost Colony!
